The General Comment session is limited to a total of 45 minutes. The Texas Open Meetings Act prohibits the Committee from deliberating on any item not on the agenda. Any discussion of the subject must be limited to a statement of fact, a statement of policy, or a proposal to place the subject on the agenda for a future meeting.

Public Testimony: A person wishing to address the EPCC on listed agenda items will be called upon by the presiding officer. Speakers are limited to three (3) minutes each, which cannot be given to other speakers. Public comment for each listed agenda item is limited to 15 minutes total time. The Committee reserves the right to table any item, discuss any item as unfinished business at the next EPCC meeting, and/or call a Special Meeting to address items to provide enough time for public comment.


