RESOLUTION NO. 2023-003-R

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF NEW HOPE, TEXAS (THE TOWN), ADOPTING THE TOWN'S AMENDED ANNUAL BUDGET FOR FISCAL YEAR BEGINNING OCTOBER 1, 2022 AND ENDING SEPTEMBER 30, 2023; PROVIDING FOR SEVERABILITY, CONFLICTS AND SAVINGS, AND AN EFFECTIVE DATE.

WHEREAS, the Town of New Hope, Texas (the "Town") is a Type B general law municipality located in Collin County and is operating according to the laws applicable thereto:

WHEREAS, the Town Council of the Town of New Hope, Texas ("Town Council") approved Resolution No. 2022-006-R, and adopted the Town's annual budget for the fiscal year beginning October 1, 2022 and ending September 30, 2023 (FY 2022-2023) (the "Annual Budget") at its Town Council meeting, open to the public, on September 7, 2022:

WHEREAS, the Town Council has further reviewed the Annual Budget and related appropriations and recommends that the Annual Budget be amended as shown in Exhibit A, attached hereto and incorporated for all purposes herein; and

WHEREAS, the Town Council finds that is in the best interest of the Town and its citizens to amend the Annual Budget, in accordance with <u>Exhibit A</u>, for sound fiscal management.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF NEW HOPE, COLLIN COUNTY, TEXAS, THAT:

- <u>Section 1.</u> <u>Recitals Incorporated.</u> The above findings are incorporated into the body of this Resolution for all purposes as if fully set forth herein.
- <u>Section 2.</u> <u>Adoption of Amended Budget.</u> The Town's Annual Budget for FY 2022-2023 is hereby approved, amended, and adopted in accordance with the attached <u>Exhibit A</u> on behalf of the Town (the "Amended Budget"). All expenditures of Town funds shall be made in accordance with the Amended Budget or as subsequently amended according to law.
- <u>Section 3.</u> <u>Severability.</u> Should any word, clause, phrase, paragraph, or section of this Resolution be adjudged or held to be void or unconstitutional, the same shall not affect the validity of the remaining portions of this Resolution, which shall remain in full force and effect.
- <u>Section 4.</u> <u>Conflicts and Savings.</u> All resolutions and provisions of resolutions of the Town in conflict with the provisions of this Resolution are hereby repealed, and all resolutions and provisions of resolutions of the Town not in conflict with the provisions of this Resolution shall remain in full force and effect.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall be effective immediately from and after its passage by the Town Council.
